No. KV/2.11/2006/AMN/902006/410/P :- WHEREAS the Government of Gujarat, in exercise of the powers conferred by sub-section (3) of section 3 of the Bombay Provincial Municipal Corporations Act, 1949 (Bom. LIX of 1949) has altered the limits of the City of Ahmedabad under the Government Notification Urban Development and Urban Housing Department No. KV-54/86 WBA-1084-107(I)-P, dated the 5<sup>th</sup> February, 1986;

AND WHEREAS the Government of Gujarat, in exercise of the powers conferred by clause (2) of article 243Q of the Constitution of India has further altered the limits of the City of Ahmedabad under the Government Notification Urban Development and Urban Housing Department No. KV/25/2006/AMN/902006/410/P, dated the 14<sup>th</sup> February, 2006;

AND WHEREAS having regard to the population of the areas, the density of the population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance of the areas, it is considered necessary to include certain areas in the existing limits of the City of Ahmedabad and to exclude certain areas from the existing limits of the City of Ahmedabad;

NOW THEREFORE in exercise of the powers conferred by clause (2) of article 243Q of the Constitution of India, the Government of Gujarat hereby specifies the entire areas of the Municipalities and Gram Panchayats as specified in the Schedule A annexed hereto and certain Revenue Survey Numbers/Block Numbers of the Revenue Villages as specified in Schedule B annexed hereto, to be the larger urban area and includes such larger urban area within the limits of the City of Ahmedabad and such areas shall form the part of the City of Ahmedabad; and excludes certain survey numbers of the Revenue Villages as specified in the Schedule C annexed hereto, from the limits of the City of Ahmedabad.

The Government land situated within the areas of the Municipalities, Gram Panchayats and Revenue Villages specified in the said Schedule A and Schedule B respectively shall not vest in the Ahmedabad Municipal Corporation.
