1. Background

The Ahmedabad Urban Development Authority (AUDA) was established in 1978, by the Government of Gujarat to facilitate the planned and sustainable growth of areas beyond the jurisdiction of Ahmedabad Municipal Corporation (AMC). AUDA is responsible for preparing and implementing development plans, town planning schemes, and infrastructure projects, ensuring well-regulated urban expansion.

AUDA's jurisdiction spans 1,866 sq. km., covering Ahmedabad city, 5 growth centers, and 169 villages. It plays a key role in the development of roads, sewerage, water supply, and other civic amenities, along with regulating private development as per the approved plans. A significant responsibility of AUDA is the management, expansion, and maintenance of the Sardar Patel Ring Road, a critical infrastructure asset ensuring seamless urban mobility.

As a part of its endeavor AUDA has resolved to take up capacity augmentation of Sardar Patel Ring Road in HAM mode in 2 packages. Now AUDA invites expression of interest from reputed consulting firms to act as Independent Engineer for both these packages.

2. Invitation for Expression of Interest (EoI)

The Executive Engineer, AUDA, for and on behalf of the Government of Gujarat, invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested firms shall provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

3. Description of Services

The consulting services ("the Services") include Independent Engineer services for below mentioned 02 packages for Six Laning of Sardar Patel Ring Road.

4. Short-listing Criteria:

a) General:

1. The consultants shall submit EOI either in sole capacity or in JV. In case of Joint Venture, the maximum number of Joint Venture partners is limited to 2 (i.e. one lead + 1 JV partner). Any entity which has been barred by the Ministry of Road Transport and Highways (MORTH) or its implementing agencies or any government agency/institute/authority for the works of Expressways, National Highways, State Highways, ISC, EI Works and other infrastructure projects and the bar subsists as on the date of application, would not be eligible to submit the EOI, either individually or as a member of a Joint Venture.
2. No Bidder shall submit more than one EOI for the Project. A Bidder submitting EOI individually or as a member of a Joint Venture shall not be entitled to submit another EOI either individually or as a member of any Joint Venture, as the case may be
3. The EOI must be properly signed as detailed below:



- by the proprietor in case of a proprietary firm
 - by the partner holding the Power of Attorney in case of a firm in partnership (A certified copy of the Power of Attorney on a stamp paper of Rs. 100 and duly notarized shall accompany the Proposal).
 - by a duly authorized person holding the Power of Attorney in case of a Limited Company or a corporation (A certified copy of the Power of Attorney on a stamp paper of Rs. 100 and duly notarized shall accompany the proposal).
 - by the authorized representative in case of Joint Venture
4. In case a Joint Venture of firms, the proposal shall be accompanied by a certified copy of legally binding Memorandum of Understanding (MOU) on a stamp paper of Rs.300, signed by all firms to the joint venture confirming the following therein:
- Date and place of signing
 - Purpose of Joint Venture/Association (must include the details of contract works for which the joint venture has been invited to bid)
 - A clear and definite description of the proposed administrative arrangements for the management and execution of the assignment. Name of Lead Firm and other partner of JV should be clearly defined in the MOU
 - An undertaking that the JV firms are jointly and severally liable to the Employer for the performance of the services
5. JV composition cannot be changed after shortlisting in the EOI stage.

b) Minimum Requirements:

1. The firm must be registered under the Indian Companies Act or the Registrar of Firms. In case of JV, both members must meet this criteria.
2. The bidder must have a **minimum of 10 years of experience** in providing relevant consulting services to government agencies/authorities. The duration of each project will be calculated as the difference between the project start and end date. In cases where multiple projects overlap, the overlapping duration will be



counted only once towards the total experience.in providing similar consultancy services to government agencies. Experience of services provided to government agencies shall only be considered for evaluation. In case of JV, any one member should meet 75% of the criteria i.e. 7.5 years & the other member should meet 25% of the criteria i.e. 2.5 years.

3. Aggregate turnover for the **last five financial years must be more than 35 crore**. In case of **JV both the members must meet this criterion on individual basis and jointly they should meet 150% of the criteria i.e. 52.5 crore of aggregate turnover in last five financial years**. No escalation factors shall be considered. Last five financial year can be considered as **2019-20 to 2023-24**. The turnover must be certified by CA certificate with valid UDIN number.
 4. Bidder shall have positive net worth as on 31.03.2024. In case of JV, both the members must meet this criterion on individual basis.
 5. Experience of completing consultancy service assignment to government agency/authority for at least one highway project of DPR/AE/IE/PMC with a **minimum length of 75 km of minimum 4 lane with NH/SH configuration in the last five years**. In case of JV both the members must meet this criterion on individual basis. For the avoidance of doubt, only those projects shall be considered in which length of the project highway as difference between the start point and end points is 75 km with 4/6 lane specification. A single contract/project having multiple packages with aggregate length of 75 km 4/6 lane specification shall not be considered. No weightage shall be given to 2 lane projects.
 6. Experience of at least one consultancy project of DPR/AE/IE/PMC for a government agency on PPP mode. This shall be in addition to the project provided against the criteria given in 5. (b) 5. In case of JV any one member must meet this criteria.
- c) **Preferential Qualification:**
- Proven expertise in handling DPR& AE/IE assignments for SH and NH for 4 lane and above configuration
 - Experience in advisory services for asset monetization for government agencies



- Experience of DPR/AE/IE for bridge projects
- Availability of road inspection technology
- Regional experience in Gujarat
- Availability of a highly qualified technical team

5. Requirements for Proposal:

The Expression of Interest (EoI) must include the following:

- Certificate of Incorporation, PAN and GST certificate of firm
- A letter on company letterhead as per Annexure I.
- Short overview of the company's profile and structure including contact details
- Project list as per Annexure II, covering the work completed in past five years aligning with the EOI requirement and short-listing criteria
- CA certified turnover certificate as per Annexure III along with audited profit & loss statement reflecting financial capabilities of past five financial years
- Certificate from CA as proof of positive net worth for FY 2023-24/2024-25.
- Valid Power of Attorney in favor of person signing the proposal along with notarized MOU, in case of JV.

Note: All Annexures to be submitted by both the members in case of JV. The proposal must be presented with page numbering and proper index.

6. Submission Details:

- The hard copy of EOI must be submitted in **hardbound only**. EOI must include sufficient supporting documentation to substantiate experience relevant to the shortlisting criteria.
- The document should not exceed **100 pages (single-sided)**, excluding appendices. Appendices shall only include experience certificates from employers and profit & loss statements in support of turnover.
- Proper sealed envelop with details of name & contact number of firm (name of both the members in case of JV) clearly marked as “ **To be opened by inviting authority only**”



- Document of expressions of interest must be delivered to inviting (in person/ by post) by 15/04/2025, 17:00 Hrs.

7. Shortlisting and ranking:

Shortlisting will be done based on fulfillment of parameters given in this document.

Detailed RFP will be shared with shortlisted applicants and final Selection Process, will be done in accordance with the Quality and Cost Based Selection (QCBS) method with 70:30 weightage to Technical & Financial Proposal respectively.
